The County of Sheridan is requesting CDBG funds for a project to renovate a building at the Sheridan County Fairground in Gordon, Nebraska into the Gordon Event Venue. The total estimated project cost is \$950,000. Cost, with total CDBG funding in the amount of \$600,000. The CDBG total includes \$25,000 for General Administration; \$5,000 for Construction Management costs; and 33% matched funding of \$500,0000from fundraising by the Sheridan County 4-H Foundation and Sheridan County Agricultural Society, and pledge of building, a 13% Match.

The project activities include:

- Project Activity 03E \$600,000. Renovation of the eastern most building at the Sheridan County Fairgrounds. This includes new metallic paint, installation of new doors and windows, new electrical line, drywalling and insulation inside building, construction inside of bathrooms, kitchen, meeting room and storage rooms, HVAC and generator, acoustic tile, sprinkler system
- Project Activity 4.3a Construction Management \$25,000
- Project Activity 21A General Administration \$5,000

All funds will be utilized for the National Objective of LMI to benefit low- and moderate-income people. There will be no persons displaced as a result of CDBG activities. ADA Compliant bathrooms and access are included in the plans for this building.

The grant application will be available for public inspection at the Sheridan County Clerk's Office. All interested parties are invited to attend this public hearing at which time you will have an opportunity to be heard regarding the grant application.
