COMMISSIONERS MINUTES

MAY 20, 2019

The Sheridan County Commissioners met in regular session at 9 A.M. in the Commissioners Office, Courthouse. All members present. Paul stated that the meeting would be conducted in accordance with the provisions of the Nebraska Open Meeting Act. Messersmith made a motion to accept the agenda. Krotz seconded the motion. All voted aye. Krotz made a motion to approve the minutes of 5-13-2019. Messersmith seconded the motion. All voted aye.

The board signed claim checks and approved road claim for \$101,968.00 for a new truck. Salary claims were approved. General \$186,213.52; Road \$82,758.28; Weed \$5,071.71.

Jeremy Harris and Phillip Berger of Manna Systems presented an overview of technology services offered by the firm. The board requested a detailed written proposal for consideration.

Mark Loosvelt met with the board to get clarification on the status of an access road that is not on the County system. Loosvelt was referred to the office of the County Attorney for further discussion.

Road Superintendent Tom Kuester reported that the rising water levels in the south are threatening the recent repairs to 277th Trail.

Jessica Heesacker of the Hay Springs Chamber of Commerce and Deb Galyen of Galyen Farms appeared to request a Special Designated License for a July 26 Century Farm Celebration at the The Barns at Galyen Farms. Messersmith made a motion to approve the SDL application for Hay Springs Chamber for July 26, 2019. Krotz seconded the motion. With a roll call vote all voted aye. The application will now have to be approved by the Liquor Commission.

The board reviewed a letter from Gordon Golf & Country Club requesting an extension of hours. Krotz made a motion to approve the request from Gordon Golf and Country Club to extend the hours for their liquor license on Sunday, May 26, 2019 from 8 A.M. to noon. Messersmith seconded the motion. With a roll call vote all voted aye.

Assessor Tina Skinner visited with the board about hearing dates for Property Valuation Protests. It was agreed to start the hearings on the afternoon of Monday, June 24, 2019.

The board reviewed the Blue Cross Blue Shield sub group applications for the coming fiscal year. Krotz made a motion to approve the BC/BS sub group applications approving the

policy with a \$1,500 deductible and monthly premium of \$909.28, along with the Dental PPO Plan. Messersmith seconded the motion. With a roll call vote all voted aye.

The board reviewed the applicants for the Building & Grounds Superintendent. The board interviewed Jeff Davis. Krotz made a motion to make an offer of \$20/hour plus benefits to Jeff Davis for the position of Building & Grounds Superintendent. Messersmith seconded the motion. With a roll call vote all voted aye.
