## COMMISSIONERS MINUTES APRIL 27, 2021

The Sheridan County Board of Commissioners met in regular session and by zoom at 9:05 A.M. on April 27, 2021. Zoom ID 3358213334 Passcode 625274. All members were present along with Sindy Coburn County Clerk, Renee Thies County Treasurer & Richard Cross Road Superintendent. Paul stated that the meeting would be conducted in accordance with the provisions of the Nebraska Open Meeting Act. This meeting was posted on the official county website and published in the Sheridan County Journal Star on April 21, 2021. Messersmith made a motion to accept the agenda. Krotz seconded the motion. All voted aye. Messersmith made a motion to approve the minutes of 4-20-2021. Krotz seconded the motion. All voted aye.

Joe O'Donnel representing the Rushville American Legion appeared to request the use of the Courthouse parking lot for a school reunion event on July 3. The board approved the request.

Deputy County Attorney Jamian Simmons met with the board through Zoom. Simmons is requesting the approval of a subdivision of 10 acres in Section 6 Township 33 Range 41 for RMAK Farms LLC. Krotz made a motion to approve Resolution #-2021-7 authorizing the subdivision request for RMAK Farms LLC. Messersmith seconded the motion. With a roll call voted aye.

Road Superintendent Richard Cross presented a report to vacate and abandon one mile of 620<sup>th</sup> Road west of 320<sup>th</sup> Lane. This request was originated by Gerald and Joyce Johnson. Messersmith made a motion to approve Resolution #2021-8 setting a hearing date of May 25, 2021 at 9:30 A.M. to listen to any public comment regarding any concern about this road closing. Cross will send letters to all concerned parties and will publish in the Sheridan County Journal Star and post on the website.

Cross reported that the cost of replacing E-911 road signs will be approximately \$9500 per road district. He plans to complete one district per year and he has it divided into 5 districts. The board felt the necessity to get it done sooner than later.

Sheriff Jeff Brewer reported that he has one officer that just got back from training at the academy and one that is going. Brewer stated that all patrol vehicles now have fire extinguishers in them, thanks to a grant he was able to secure.

The board reviewed a request for a Special Designated Liquor License. Messersmith made a motion to approve the request for a SDL for Fuel Grill LLC for May 22, 2021 from 4 P.M. to 1 A.M. at Galyen Farms. Krotz seconded the motion. With a roll call vote all voted aye.

Extension Educator Jack Arterburn reported on recent and upcoming events and projects. Jeremy Harris of MANNA met with the board via Zoom to discuss any requests in the IT department.
