Messersmith stated that the meeting would be conducted in accordance with the provisions of the Nebraska Open Meeting Act. This meeting was posted on the official county website and published in the Sheridan County Journal Star on September 14, 2022.

Krotz made a motion to adopt Resolution #2022-17 setting the final tax request for the 2022-23 General Fund at \$4,224,229.97 and the Building Fund at \$40,678.60. Kling seconded the motion. With a roll call vote all voted aye.

Kling made a motion to adopt Resolution #2022-18 adopting the 2022-2023 Sheridan County Budget. Krotz seconded the motion. With a roll call vote all voted aye.

The board signed claim checks and audited and approved salary claims.

Road Superintendent Richard Cross reported that he has obtained an estimate from a Gering firm for a traffic study on 470th Lane southwest of Hay Springs.

The board discussed a 50/50 cost share project with Road District #31. Cross said they will begin as soon as possible.

Sheriff Jeff Brewer and Jail Supervisor Jodi Elsea presented a grant proposal for ARPA funds to make certain safety and security upgrades to the jail. The proposal will be sent to the County Attorney for review.
