

COMMISSIONERS MINUTES

OCTOBER 21, 2025

The Sheridan County Board of Equalization met in regular session and by Zoom (ID#87981717732 Passcode# 625274) at 9:03 A.M. on March 25, 2025. Commissioner Krotz and Messersmith present along with Deputy Clerk Paige Rager, Treasurer Renee Thies, Clerk of District Court Carol Stouffer and Interim Road Superintendent Rod Norton. Commissioner Kling was excused.

Krotz stated that the meeting would be conducted in accordance with the provisions of the Nebraska Open Meeting Act. This meeting was posted on the official website and published in the Sheridan County Journal Star on October 15, 2025.

Messersmith made a motion to accept the agenda. Krotz seconded the motion. With a roll call vote Krotz and Messersmith voted aye. Krotz made a motion to approve the minutes of 10-14-2025. Messersmith seconded the motion. With a roll call vote Krotz and Messersmith voted aye.

The board audited and approved salary claims and signed claim checks.

The board reviewed a contract from the County's Health Insurance provider. After review, Krotz made a motion to sign the contract. Messersmith seconded the motion. With a roll call vote Krotz and Messersmith voted aye.

The board reviewed three resolutions set forth for approval for the transfer of funds from the General fund to the Road, Reappraisal and Weed funds to provide adequate funding for the 2025-2026 fiscal year. After review, Messersmith made a motion to approve Resolution #2025-25 authorizing the Treasurer to transfer \$1,315,570.03 from the

General fund to the Road fund. Krotz seconded the motion. With a roll call vote all voted aye.

Krotz made a motion to approve Resolution #2025-26 authorizing the Treasurer to transfer \$70,095 from the General fund to the Reappraisal fund. Messersmith seconded the motion. With a roll call vote all voted aye.

Messersmith made a motion to approve Resolution #2025-27 authorizing the Treasurer to transfer \$101,377.22 from the General Fund to the Weed Fund. Krotz seconded the motion. With a roll call vote all voted aye.

Interim Road Superintendent Rod Norton was present to give an update on the road department and on-going projects. Norton informed the board that the department will start roadside mowing next week.

Building and Grounds Superintendent Jeff Davis was not present.

Sheriff Jeff Brewer was not present.

Brock Ortner, Extension Livestock Systems Educator was present to give an update of the Extension activities and upcoming events. Ortner informed the board that a few Extension board members are nearing the end of their terms and that Mark Haller has expressed interest in becoming a member.
