## **COMMISSIONERS MINUTES**

## **DECEMBER 16, 2025**

The Sheridan County Board of Commissioners met in regular session at 9:15 A.M. on December 16, 2025. All members present along with Clerk Sindy Coburn, Assessor Tina Skinner, Clerk of District Court Clerk Carol Stouffer and Interim Road Superintendent Rod Norton.

Krotz stated that the meeting would be conducted in accordance with the provisions of the Nebraska Open Meeting Act. This meeting was posted in the Sheridan County Journal Star and on the official website December 10, 2025.

Messersmith made a motion to accept the agenda. Kling seconded the motion. With a roll call vote all voted aye. Messersmith made a motion to approve the minutes of 12-9-2025. Kling seconded the motion. With a roll call vote all voted aye.

The board audited and approved claims.

The board visited about increasing the amount of cash in lieu of health care benefits. Kling made a motion to increase the cash in lieu of health insurance payments for qualified county employees to \$600/month starting in January 2026 with the board reviewing at their discretion. Messersmith seconded the motion. With a roll call vote all voted aye.

Interim Road Superintendent Rod Norton was present to give an update on the road department and on-going projects. Norton informed the board that the bridge inspections are all done.

Norton informed the board that the wood chipper is coming this week and that all blades and trucks are out and going.

Sheriff Jeff Brewer was not present.

Building and Grounds Superintendent Jeff Davis was not present.

Budget Coordinator Caleb Johnson phoned in to discuss the development of the salary resolution for the elected officials for the 2026-2030 term. Johnson recommended a base salary for 2026, and an annual increase based on the Consumer Price Index for each succeeding year. The board will do some more reviewing and finalize the resolution on December 23, 2025.

The board also visited with Johnson about the Extension Sinking Fund. The board has made the decision to do away with Sinking funds and was needing clarification on how to proceed. Johnson advised that when its time to purchase a vehicle the monies can be spent directly out of the fund, or the monies can be transferred to the General Fund.

At 11 A.M. the board opened a public hearing on roadside mowing charges. Present landowner was Florence J Walters. Walters showed the board pictures of the property that she was assessed the fee for mowing. (Section 22, Township 31, Range 41) This property is not easy to mow due to the steep slope. Walters also showed the board pictures of other property that was close that was not mowed and not assessed by the county. Walters feels that it is unequal treatment.

Kling made a motion to remove the assessment for Florence J Walters after evidence was provided. Messersmith seconded the motion. With a roll call vote all voted aye.

Kling made a motion to adopt Resolution #2025-31 assessing the following tax payers for roadside mowing.
